Ms. Cerbone stated the proposed Fiscal Year 2024 budget will be presented at an upcoming meeting. for budgeting purposes, it is important to know if the CDD plans to own any improvements during Fiscal Year 2024 and if any property will transition to on-roll.

Mr. Caputo stated that development is expected to commence April 2023. Mr. Earlywine stated, given that timing, some infrastructure improvements will likely be constructed by Fiscal Year 2024. A Board Member stated that land will be platted and tracts will be transferred to the CDD in fall 2023; the CDD will take ownership of improvements but not maintenance and control until all the improvements are completed and turned over. Ms. Cerbone stated it is helpful to budget for any anticipated costs, even if funds are not expended.

Discussion ensued about potential expenses to include in the Fiscal Year 2024 budget.
