# FIRST ORDER OF BUSINESS Call to Order/Roll Call

Mr. Kantarzhi called the meeting to order at 11:52 a.m. Supervisors Caputo, Frye, Tim Smith and Seifel were present. Supervisor Candice Smith was not present.

Mr. Kantarzhi presented Resolution 2023-10 and the proposed Fiscal Year 2024 budget, which is unchanged since it was last presented. It is a Landowner-funded budget with expenses funded as they are incurred.

Ms. Cerbone stated this will allow the Chair or Vice Chair to work with the Developer and District Counsel to assign the site work contract to the CDD. The Developer will continue funding the CDD; however, payments to the site contractor will come from the CDD.

On MOTION by Mr. Frye and seconded by Mr. Seifel, with all in favor, assignment of the Site Work Contract, was approved.

Mr. Kantarzhi discussed the Field Ops budget and the need to enable Field Ops Staff, District Counsel and the Chair to enter into Field Ops agreements in line with the Field Ops budget, in between meetings; the agreements and/or expenses would then be ratified later.

Roadway maintenance	\$ 5,000
Contingencies	\$20,000

On MOTION by Mr. Frye and seconded by Mr. Smith, with all in favor, authorizing Field Ops Staff, District Counsel and the Chair to enter into and execute Field Ops agreements in line with the budget, between meetings, was approved.

Ms. Cerbone stated, unless something changes, Rizzetta & Company will take over as the District Management firm within the coming months, following the issuance of bonds. She noted that the contract likely includes a termination period of 30 or 60 days.
